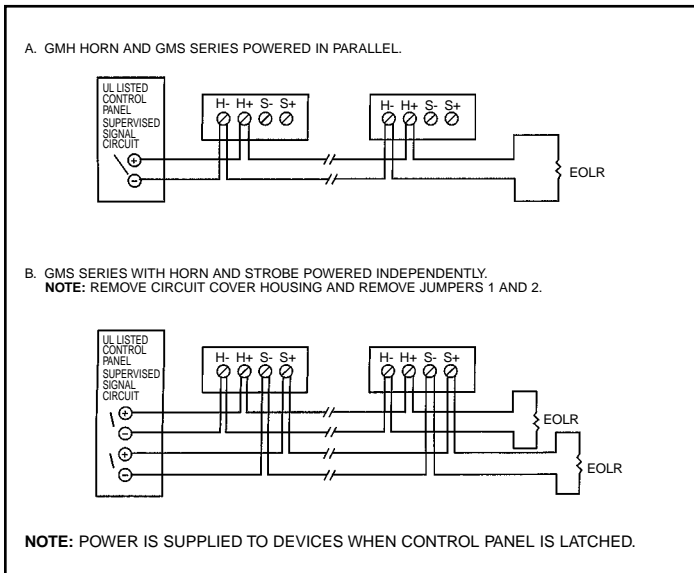

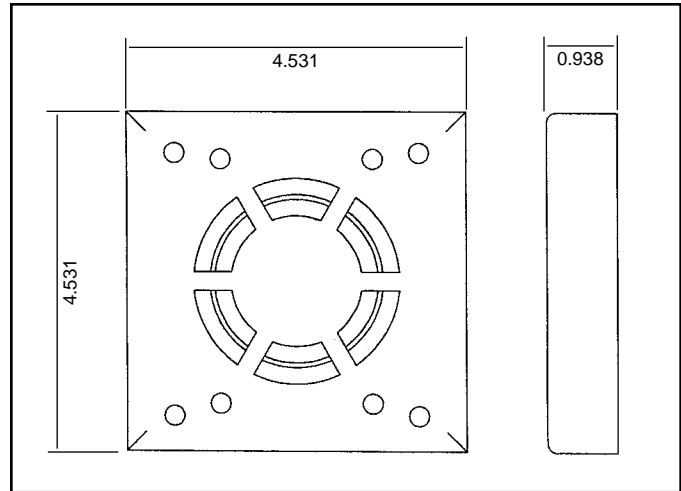

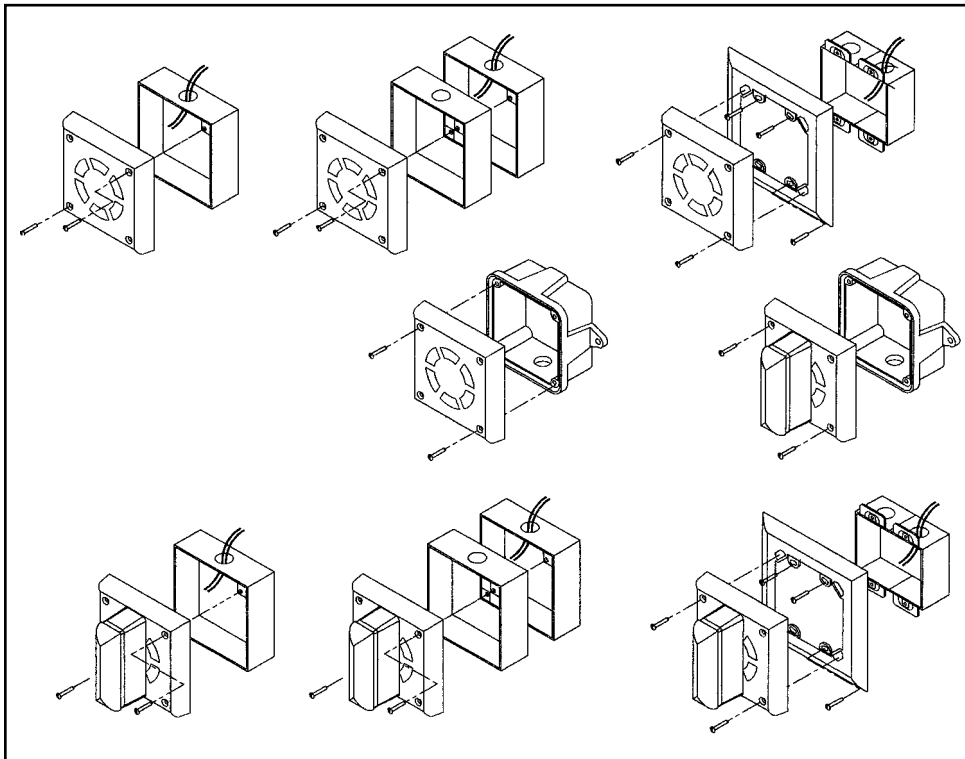
## Wiring Diagrams

 Gangable 2 gang switch/masonry outlet boxes 1 1/2" deep minimum (with trim plate)  
 WGBB Gentex weatherproof back box

## Architect & Engineering Specifications

The audible or audible/visual signal shall be Gentex model GMH or GMS or approved equal, and shall be listed by Underwriters Laboratories per UL 464, and when combined with the strobe option the strobe shall also be listed per UL 1971. The notification appliance shall also be listed with the California State Fire Marshal (CSFM) and the Bureau of Standards and Appeals (NYC).

The notification appliance shall produce a peak sound output of 105dBA or greater as measured in an anechoic chamber.

The visual signal shall have a flash rate of 1Hz regardless of input voltage.

The notification appliance shall be provided with screw terminals for in and out field wiring and the strobe shall be capable of operating independently after the audible has been silenced.

The notification appliance shall be capable of mounting to a 4" square back box and a 2 gang switch box with the Gentex trim ring.
